

SAMPLE FILE - China Exports of Polypropylene; in primary forms

The purpose of this paper is to show what sort of typical analytical tables and charts are available in a standard TradeData Excel file for any product exported from China. The product chosen was “**Polypropylene; in primary forms**”. Similar information is available for any product. The information is supplied in Excel file format and the file is designed to enable efficient analysis of the underlying statistics. At the end of this paper there are listed two typical exports transactions to demonstrate the underlying exports information that is available in TradeData’s standard Excel file.

Table – Top Ten Origin Countries

The following table comes directly out of our standard excel file and shows – monthly –the top ten destination countries in terms of volumes as well as average prices per month. This table provides a convenient summary of month-to-month movements in exports. TradeData will normally supply the current year and five years of back data in its data files. However, if more data is required, in most cases, we can supply at no extra charge.

Details

There is a worksheet in the excel file that lists China details by country and average prices each month. Note these are prices at FOB basis, that is they do not include transport and insurance cost associated with the export. A small sample is below.

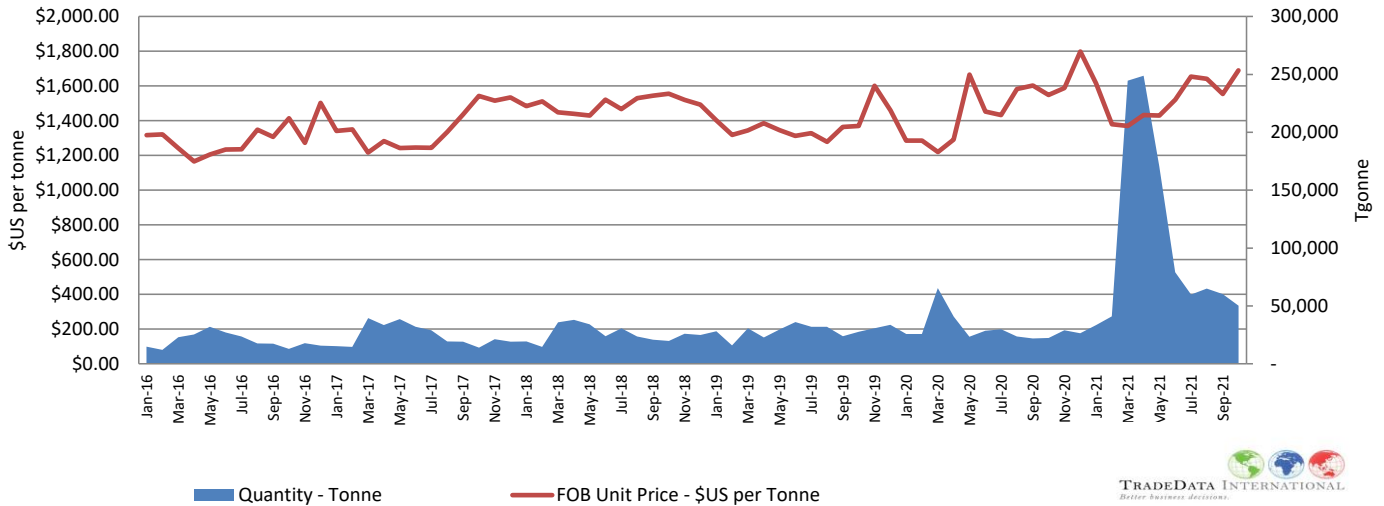

Price and Quantity

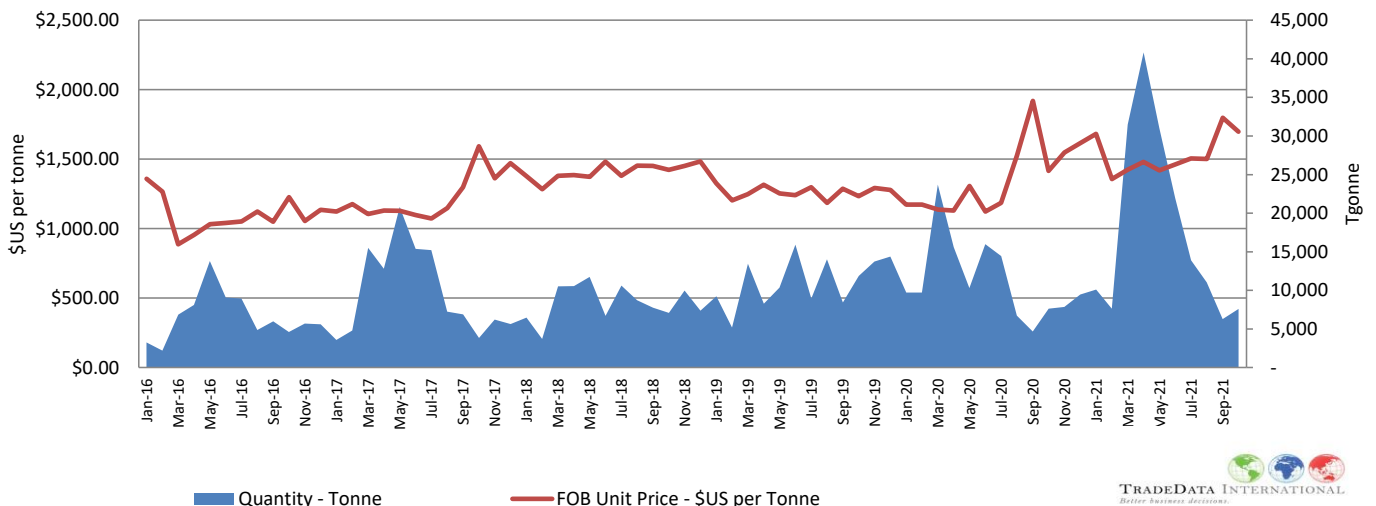
The next chart shows monthly movement in exports volumes - the blue shaded area of the chart - and in average prices on an FOB basis. Export volumes display a seasonal pattern and also a very strong surge in the second quarter of 2021. Peak export volumes are in the middle of each year. Average export prices were generally higher in 2018 and declined in 2019. Prices increased again the second half of 2020, fell in early 2021 and then recovered. The surge in exports in the first half of 2021 was associated with lower prices and saw strong increases in exports to Malaysia, the USA, Taiwan, Turkey and a range of other countries.

The excel file enables the user to select a destination country and then redraw this Price&Quantity chart to only include exports to the selected country. The chart below lists Price and Quantity where exports only to Viet Nam are selected. Like total exports, exports to Viet Nam have increased strongly in 2016 and 2017 in a seasonal pattern. Since 2018, export volumes to Vietnam have continued to increase but without the pronounced seasonal pattern and were very strong in the second quarter of 2021.

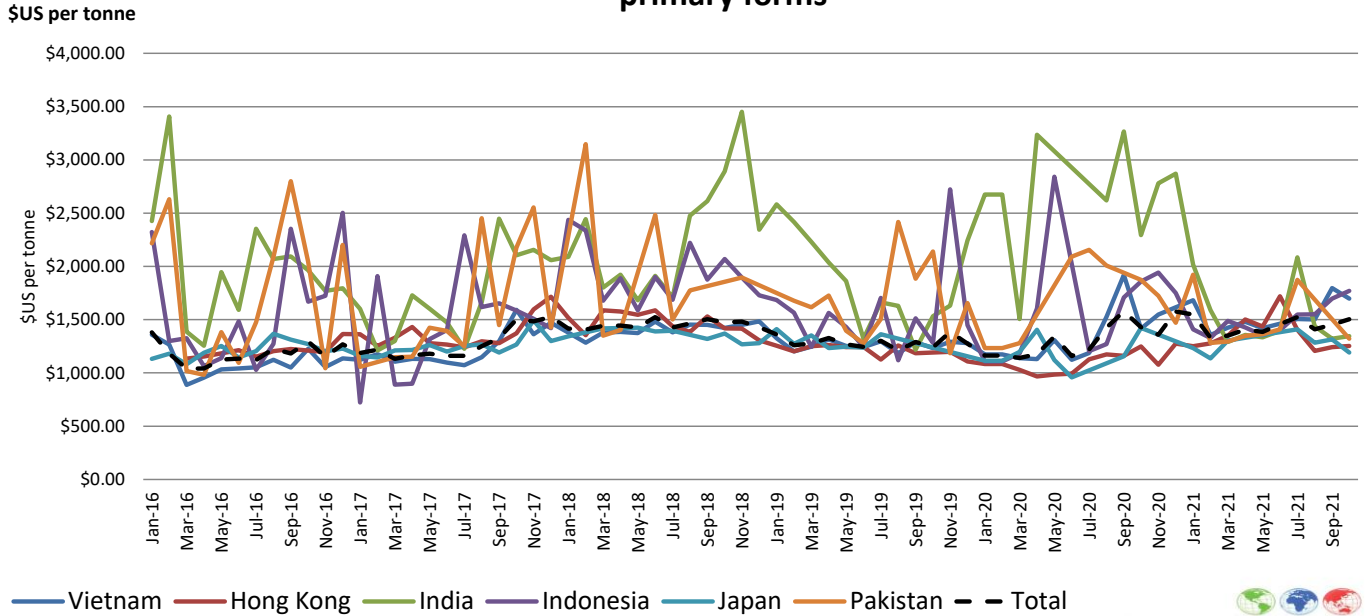
CHINA Exports of Polypropylene; in primary forms

China Exports - Average Prices - Top 6 Origin Countries - Polypropylene; in primary forms

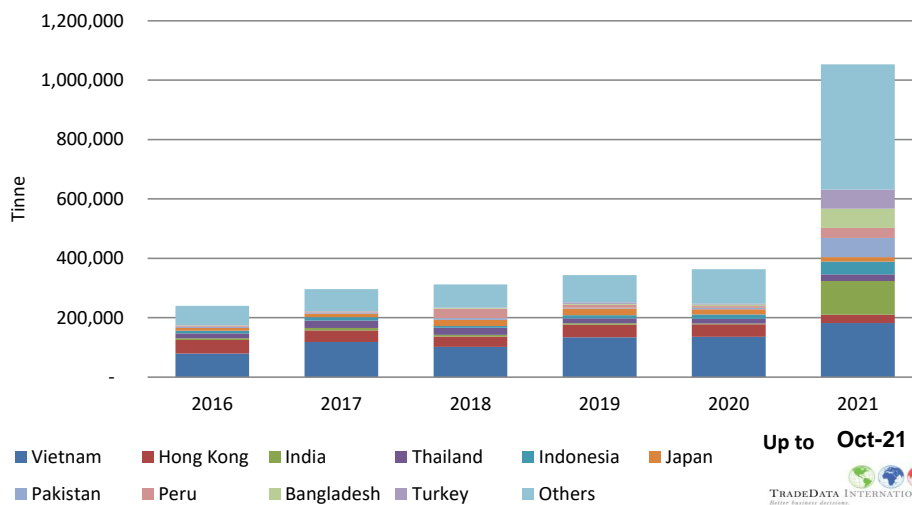

Major Supply Countries

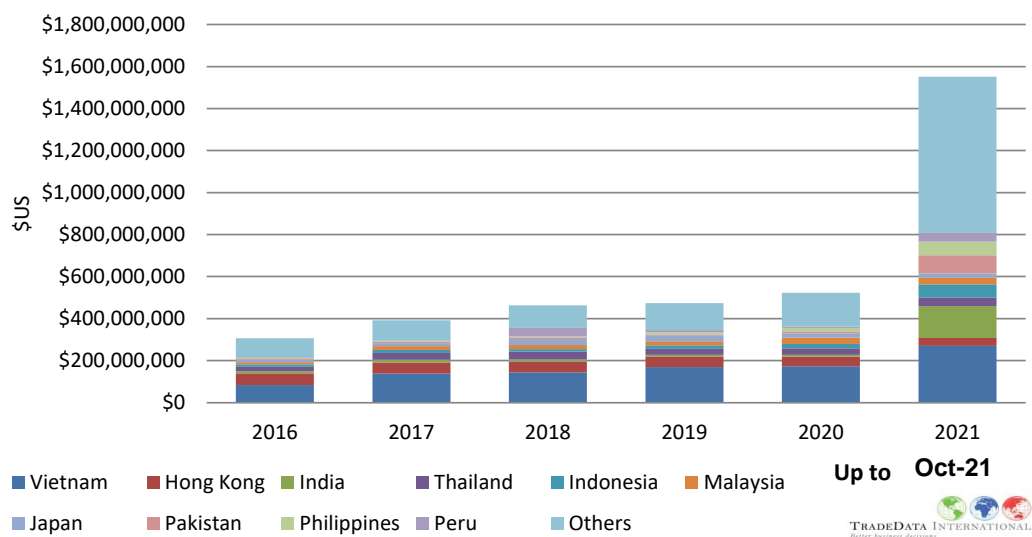

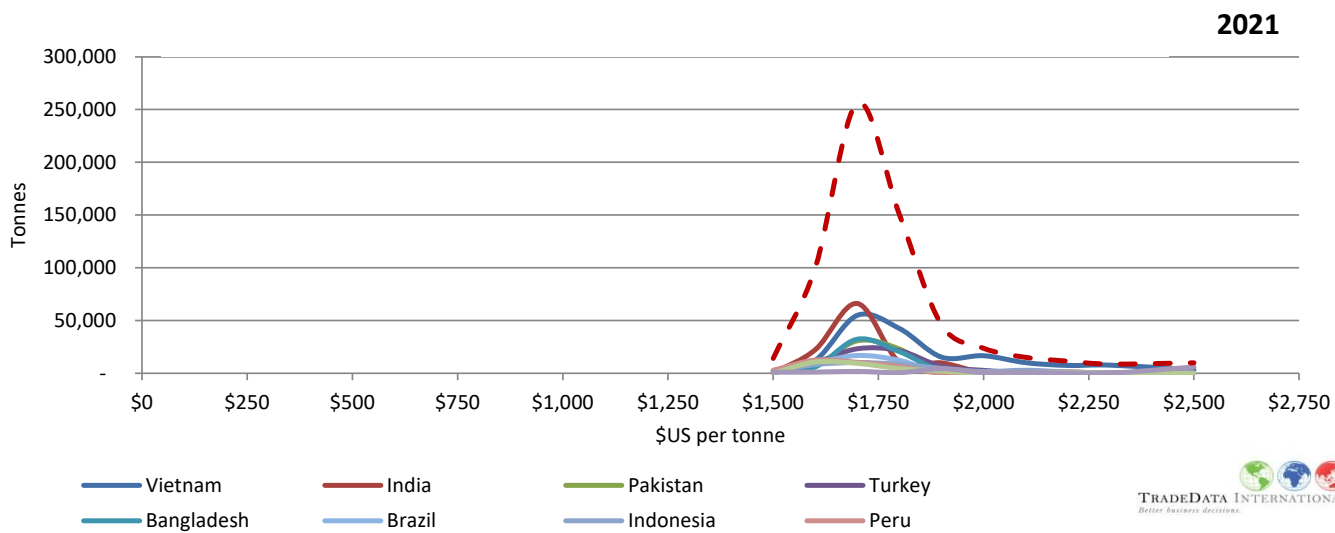
CHINA Exports of Polypropylene; in primary forms by Value

The following chart lists a Price Histogram by Country. This shows during the first 10 months of 2021, the volumes exported at different price points and the major destination country supplied at these price points. The Excel file enables the user to select different years and to the chart will redraw itself accordingly. Most export occur around \$US 1,750 per tonne.
